Practice Overview

Thomas Saunders specialises in the resolution of construction and engineering disputes, including professional negligence and energy claims, as well as a wide range of other commercial and property disputes. Thomas's practice has a particular focus on advocacy, and he regularly appears as sole counsel in the High Court and the County Court.

- URS Corporation Ltd v BDW Trading Ltd [2025] UKSC 21, [2025] 2 WLR 1095, a wide-ranging appeal concerning liability for
 dangerous structural defects. The Supreme Court considered the proper approach to 'voluntariness' in the tort of negligence,

Enforcement.

Property

- Drafting skeleton argument in an application for interim relief to restrain a sub-contractor from returning to site and damaging property following a payment dispute.

- Validation orders under section 127 of the Insolvency Act 1986.
- Applications to strike out winding up petitions, or to restrain presentation / advertisement, including petitions arising out of adjudicators' decisions.

Civil fraud

Civil fraud claims arising out of both misrepresentation and bribery, including:

- Representing a homeowner in a claim against project managers for defective works and receipt of a bribe or secret
 commission. The case settled following an 'unless' order requiring the project managers to replead their defence.
- · Acting for the contractor under a PFI contract in an £80 million fraud claim against a local authority.

Insurance

Claims arising out of insurance policies, including:

- Claims under the National House-Building Council's Buildmark policy.
- Claims against insurers under the Third Parties (Rights against Insurers) Act 2010.

Sale and supply of goods

Sale and supply of goods disputes, including claims concerning the supply of construction plant and materials such as:

- Structural insulated panels for construction of student accommodation.
- Lightweight aggregate for flood defences.
- Pumping equipment for use during construction works.

General commercial

- Advising a national retailer on the applicability of restrictions under the Health Protection (Coronavirus, Restrictions)
 (England) (No 4) Regulations 2020 (the November 2020 Covid-19 lockdown), and the enforcement options available to local authorities.

Advocacy
