Practice Overview

He has substantial experience with all common standard forms including JCT, NEC, FIDIC, and bespoke construction contracts, as well as PFI agreements, guarantees and bonds. He is also a contributor to *Keating on Construction Contracts*.

Youcef regularly represents clients in the High Court, County Court and in adjudications in his own right. Youcef has recently:

- acted as sole counsel in a one-day trial involving allegations of fraud and procuring breach of contract.
- acted as sole counsel in the High Court (TCC) on an application to enforce an adjudicator's decision, opposed on grounds of fraud.
