Public Procurement

- Leading a team of one other silk and two juniors acting for Mersey Waste Disposal Authority (MWDA) defending a claim by Covanta Energy contesting the fairness of a decision by MWDA to award a £1.2bn contract to a rival party. This case raised complex legal questions about the use of the competitive dialogue procedure and the UK's transposition of European Directives and was widely reported in the press.
- Acting for BY Development Ltd in relation to alleged flaws in the procurement process for a £2bn project to redevelop New Covent Garden Market, London.
- Acting for Alstom in the high profile and lengthy Eurostar litigation concerning the award of a EURO1.2bn contract for supply of trains. The case raised issues of equal treatment and transparency in the Utilities Contracts Regulations 2006.
- Acting for the Legal Services Commission (now Legal Aid Agency) in a number of challenges to its procurement of legal aid services, both in the High Court and Court of Appeal.
- Acting for National Express in the high profile cancellation of the Great Western train franchise competition (related to the West Coast Main Line dispute) involving the difficult legal question of Department of Transport's failure to reimburse the bidders' costs (around £40m).
- Advising a number of public bodies, including central Government, on highly topical procurement issues including the relevance of past performance, the exclusion of bidders and the use of framework agreements.
