THE SPEAKERS:

STUART MACDOUGALD-DENTON is a Chartered Architect and had over 100 expert appointments. He has worked in private architectural practice and for large main contractors, designing and/or delivering a diverse range of projects, including the Stirling Prize-winning botanical sciences laboratories Cambridge, neurological sciences labs and 2 other Further Education projects, 30 PFI and academy framework schools, a recording studio, offices, cardiothoracic, A&E and mental health hospitals, residential and student accommodation, a 1480-cell prison, defence and retail projects. He standardised the consultant appointments and re-wrote Kier's pre-construction and construction processes. He also helped validate Kier's BimXtra software.

Stuart has being preparing independent reports and giving expert opinion for over 14 years. His success in aiding settlement has meant only six disputes have resulted in appearances in the witness box. He has also acts as a construction adjudicator.

Stuart will talk about the change in role of consultants after novation, the responsibility for design co-ordination in the D&B environment, how the interface with designing subcontractors can be effectively managed, design development -v- design variation, and how the introduction of BIM may both help and hinder this.

ELIZABETH REPPER is a barrister at Keating Chambers, London who now only takes alternative dispute resolution appointments. She is ranked as a mediator in the <u>Legal 500 2015</u> and, to date, has been appointed as sole mediator and co-mediator over 70 times, including in construction, property, professional negligence, insolvency and insurance disputes.
